Developing an Activity - Key Questions

Rather than getting caught up in a "form" and focusing on the "paperwork", you might find it helpful to consider the following questions when you meet with planning committees and begin developing new activities (or revisiting old ones). Once you and your planning team have the answers to these questions, completion of your documentation form is quick and easy!

- What is the problem that is creating the need for this activity?
- What evidence do we have that this problem exists? What options are there to make it better?
- If education is the way to address this problem (maybe in addition to other things, like new policies/procedures, updated equipment, etc.), what is the fundamental level of education needed building knowledge, acquiring skill, or translating existing knowledge and skill into practice? If it's all 3, start with knowledge as the basis for building skill and practice change.
- Who needs this education in order for things to change?
- Once we do the education, how will we know that participants gained knowledge or acquired skill? How will we measure our success? (Ultimately, you might want a change in practice, but that can't be measured at the end of the activity. Focus now on what you want when learners walk out the door at the end of the activity.)
- What content items should be included to help learners get to that outcome?
- What references and resources can be used to provide the best available evidence for this content?
- How can we actively engage learners in this education, knowing that people learn better when they're active participants and not just listening to someone talk?
- What will participants need to do in order to earn their contact hours? This might involve attendance for a certain amount of time, scoring a certain grade on a post-test, completing an evaluation, providing a return demonstration, or a number of other things.
- How will we evaluate whether the activity was successful?
