Reminder--Standards for Integrity and Independence Resources

As a reminder, there are substantive changes that will impact your activity planning related to the new Standards for Integrity and Independence. The new standards, adopted by the American Nurses Credentialing Center (ANCC) and several other organizations, are designed to ensure that education is based on valid content and is free from commercial influence. The following resources are now available on the Approved Provider website-password APUNCPD.

- New documentation materials, application materials, crosswalk of changes, full standards, toolkit, manual
- Recording of Session 1 webinar introducing the new standards and highlighting changes with a focus on Standard 3-Identify, Mitigate, & Disclose Relevant Financial Relationships. Contact hours for the recording will be available until September 1, 2021, with submission of an evaluation.

EDP4 Description

When you complete your provider application, education design process number 4 (EDP4) has been updated to align with the new Standards for Integrity and Independence. EDP4 description is the process used to identify and mitigate, and disclose all relevant financial relationships for all individuals in a position to control educational content.

Here is the generic example of the process to identify, mitigate, and disclose relevant financial relationships. You can use these as guidelines, but please be sure to modify them to fit your own unique circumstances.

It is the responsibility of the nurse planner to identify, mitigate, and disclose all relevant financial relationships with ineligible companies for those with the ability to control the content of the activity. An ineligible company is entity whose primary business is producing, marketing, selling, re-selling, or distributing healthcare products used by or on patients. Financial relationships are relevant if the following three conditions are met for the prospective person who will control content of the education:

- A financial relationship, in any amount, exists between the person in control of content and an ineligible company
- The financial relationship existed during the past 24 months
- The content of the education is related to the products of an ineligible company with whom the person has a financial relationship

Our process begins with the nurse planner determining if the content will only address a nonclinical topic such as communication skills training, leadership, preceptor development, etc. If the content will only address a nonclinical topic, then the nurse planner does not need to identify, mitigate, or disclose relevant financial relationships. The activity information provided to the learners prior to the start of the activity would not include absence of a relevant financial disclosure statement.

If the content addresses a clinical topic, then the nurse planner will first complete the "Financial Disclosure Form" specific to the activity. If the nurse planner reports a financial relationship with an ineligible company, then another member of the planning committee familiar with ANCC criteria review would complete the "Mitigation Worksheet" for the nurse planner. The nurse planner cannot mitigate their own financial relationships.

The nurse planner collects and reviews the "Financial Disclosure Form" from for all those with the ability to control the content including planning committee members, speakers, and content reviews, before they can participate. Any individual refusing to complete the required disclosure will not be allowed to participate in the activity. For individuals with financial relationships noted on the "Financial Disclosure Form", the nurse planner completes the "Mitigation Worksheet". The nurse planner excludes owners or employees of ineligible companies from participating as planners or speakers unless one of the three exceptions apply:

- When the content of the activity is not related to their business lines or products
- When the content is limited to basic science or research, and they do not make care recommendations
- When they are participating as technicians to teach the safe and proper use of medical devices, and do not recommend whether or when a device is used

If the nurse planner determines that a financial relationship is relevant, the nurse planner will choose a mitigation strategy appropriate to their role in the activity. Mitigation strategies may include:

- Recusal from controlling aspects of planning and content with which there is a financial relationship (Remove/revise the role of the individual so that the relationship is no longer relevant)
- Peer review of planning decisions by persons without relevant financial relationships-
- Peer review of content by persons without relevant financial relationships (nurse planner, planning committee member, content reviewer, etc.)
- Attest that clinical recommendations are evidence-based and free of commercial bias (e.g., peer-reviewed literature, adhering to evidence-based practice guidelines)
- Divest (sell) the financial relationship
- Other methods

For activities with relevant financial relationships, the nurse planner discloses the name(s) of the individuals, name of the ineligible company(ies) with which they have a relevant financial relationship(s), the nature of the relationship(s), and a statement that all relevant financial relationships have been mitigated. The nurse planner will provide absence or presence of relevant financial information for each person with the ability to control the content prior to the start of the educational activity.

The primary nurse planner consults with the Accredited Approver Program Director with any questions related to identifying, mitigating, and disclosing relevant financial relationships.

Technology Tips

<u>Poll Everywhere</u>: Poll Everywhere is online polling software you can use in live classrooms, virtual classrooms, and hybrid experiences. It allows you to ask your learners questions for them to answer in real-time so you can use it for learner engagement and real-time assessments.

Poll Everywhere is a subscription-based software that you can use for free or upgrade to a subscription for more features.

Features I like about Poll Everywhere:

- Learners can answer using their cell phones (any cell phone that texts, not just smartphones) or by using a web link.
- There are a number of question formats that work well for a variety of different educational sessions there are standard multiple choice questions, check all that apply questions, ratings, open-ended answers, clickable images, etc. You can also customize how the answers display to learners (or if they even display at all).
- It's easy to organize and duplicate questions for a variety of sessions/activities.
- There is a Powerpoint/Google Slides plugin that allows you to simply activate questions as part of your slideshow no need to open new programs or webpages! Everything is seamless and easy to utilize for facilitators and learners.
- Questions can be created and launched in real time it's a great tool for quickly pivoting session content or making adjustments. This is especially true if you have a facilitation partner who can manage polling while you are speaking.
